These include maintaining a collaborative relationship with landowners, annual monitoring with written checklist and updates to base line documentation, promptly contacting new owners and providing orientation, requesting landowners notify KNLT for review of proposed actions that might generate easement violations, and periodically sending landowners written summaries of their easement terms.

2. The Stewardship Director is authorized to resolve any "technical" violations that have no discernible impact on conservation values and require no remediation, and make a report of such resolutions to the KNLT

Board at the next regular meeting.

3. The Stewardship Director will notify the Executive Director of any potential or suspected violations of an easement, and provide documentation of site visits and other supporting materials. The Executive Director will meet with the landowners and seek resolution to the conflict after review of all relevant documentation. The ED will evaluate any suspected violation as major (cost more than \$5,000 to remediate or threat to core conservation values) or minor violation (less than \$5,000 to remediate with no threat to core conservation values), the entity responsible for the violation, whether the violation was intentional, mitigating circumstances, any partners that should be involved, and any precedent that might be set by the response.

4. The ED will document by letter to the landowner the information provided to the landowner, any agreements to avoid or correct the violation that are reached, a time line and designation of responsible parties for each action and cost. The Stewardship Director will monitor agreed corrective actions and compliance with the timeline that will be established for each corrective action.

5. Proposed corrective actions will be reviewed and approved at the next full board meeting. If there is a major violation where time is of the essence or the landowner refuses to take corrective actions, allow access to inspect, or will not meet to discuss corrective actions, the ED may seek a Temporary Restraining Order or injunctive relief with the documented approval of the Executive Committee prior to the next board meeting. Terra Firma insurance provisions for notice will be met prior to any formal legal action to enforce easements covered under the policy.

6. Enforcement litigation shall only go forward as a last resort for

otherwise unresolved major violations following approval by the KNLТ Board informed by advice and support from KNLТ counsel and staff advisors from Terra Firma.

7. The Board shall authorize expenditure of Stewardship Endowment Funds to cover costs of enforcement, and seek recovery of such costs in the authorized litigation. Particular considerations will be documented regarding whether litigation must proceed against the original donor, successor owners, or third party violations. Particular consideration will also be given to any precedent (good or bad) that might be set by the decision to litigate, the potential for unrecovered cost for enforcement, and any partners that also maintain a property interest in the land (e.g., USDA easements, FILO easement, Heritage Board easements, resulting from mitigation programs).
