Funding is made available to conservation groups for purchasing and protecting forested bat habitat, as well as, for habitat management, monitoring and research. KNLT accepts funds as a fiscal agent for the IBCF and agrees to disburse those assets to designated beneficiaries. Assets held by KNLT for the IBCF are classified as "current liabilities" on the statement of financial position. IBCF funds are listed in the 990 in Part X under "Liabilities."
