OUR EFFORTS BEGAN WITH RAISING FUNDS IN PARTNERSHIP WITH THE OFFICE OF KENTUCKY NATURE PRESERVES TO SAFEGUARD KENTUCKY'S LARGEST REMAINING TRACT OF OLD GROWTH FOREST NOW KNOWN AS BLANTON FOREST STATE NATURE PRESERVES. SINCE 1995, KNLT HAS PROTECTED MORE THAN 60,000 ACRES OF WILDLANDS. THROUGH 2024, KNLT HAS DIRECTLY PROTECTED OVER 19,000 ACRES AND PARTNERED ON THE PROTECTION OF AN ADDITIONAL 40,500 ACRES.
